The solution should be warmed to body temperature before administration. Intravenous injections should be given slowly. Observe aseptic precautions

5.1 Pharmacodynamic properties

Milk fever which is characterised by hypocalcaemia is caused by an acute drop in the level of ionised calcium. Administration of calcium borogluconate by subcutaneous or slow intravenous injection replenishes plasma calcium levels and reverses the hypocalcaemia.

Shelf life of the veterinary medicinal product as package for sale: 3 years

The product does not contain an antimicrobial preservative. The product is intended for single use only. Any product remaining in the bottle after withdrawal of the required dose should be discarded

6.5 Nature and composition of immediate packaging

Calciject 40 is marketed in either 400 ml Amber Type III glass vials sealed with black rubber wads and aluminium screw caps, or 400 ml polypropylene containers sealed with grey bromobutyl bungs and aluminium caps. Not all pack sizes may be marketed.
